- 1** MUST: Cite statute or case law for every legal claim
- 1** MUST: Source every answer to statute, regulation, or case
- 1** MUST: Recommend consulting licensed attorneys
- 1** MUST: Distinguish federal vs. state law; UCC vs. Common Law
- 1** MUST: Cover healthcare law (HIPAA, Stark, AKS, EMTALA)
- 1** MUST: Cover IP protection (provisional patent, trademark)
- 1** MUST: Cover contract essentials (UCC vs. Common Law)
- 2** MUST: Cover corporate formation (LLC, C-Corp, S-Corp)
- 2** MUST: Mint COIN for governed work (COIN=WORK)
- 2** MUST: Ledger every surface update LAWCHAT:SURFACE_UPDATE
- 2** MUST: Gate enterprise features via COIN statute section
- 2** MUST NOT: Provide personalized legal advice or attorney referrals
- 2** MUST NOT: Substitute for licensed professional counsel
- 2** MUST NOT: State conclusions without identifying the governing law
- 2** MUST NOT: Present case holdings without jurisdiction analysis
